**Access Capital Partners hits final close on its first
European direct infrastructure Fund at €371 million**

Access Capital Partners (“Access”) is pleased to announce the final closing of ACIF Infrastructure (the “Fund”) with Total Commitments of €371 million, surpassing its initial target of €250 million.

With this new Fund, Access welcomes a diverse group of new and existing investors, including public and corporate pension funds, insurance companies, asset managers, family offices and foundations from across Europe.

ACIF Infrastructure is a direct investment fund targeting investments in European operational and cash yielding infrastructure assets, alongside financial and industrial partners. To date, the Fund has already invested in seven assets across a broad spectrum of sectors including transportation, utilities, renewable energy and telecommunications. A first yield distribution will be made to investors shortly after closing.

Access’ Managing Partners, Agnès Nahum and Philippe Poggioli, commented: “This closing is a testament to investors’ confidence in Access’ strategy and market positioning. As we continue seeing compelling infrastructure investment opportunities in Europe, we are grateful to investors for their support to this fundraise, which will allow us to continue pursuing these opportunities in the coming years and build on our successful track record of investing in European infrastructure assets.”

Access invests in infrastructure through a combination of direct and fund investments. With the closing of ACIF Infrastructure, Access has approximately €1.3 billion in infrastructure assets under management, including co-mingled funds and segregated mandates. The dedicated infrastructure team is led by three Partners, Aymeric Paul (Head of Infrastructure), Manish Pandey (Head of Direct investments) and Tomas Wegelius.
